Ooreenkomsdig artikels 175 en 177 van die Wet tot Konsolidasie van die Kieswette, 1946 (Wet 46 van 1946), saamgelees met artikel 9 van die Ordonnansie op die Instelling van 'n Gekose Kleurlingraad van Suidwes-Afrika, 1966 (Ordonnansie 29 van 1966), verklaar ek hiermee dat daar weens die ontruiming van die setel van mnr. A. J. F. Kloppers ingevolge artikel 13(b) van genoemde Ordonnansie as gevolg van sy awesigheid van 'n hele gewone sessie van die Gekose Kleurlingraad van Suidwes-Afrika sonder spesiale verlof van genoemde Raad, met ingang van 29 Junie 1978 'n vakature ontstaan het in die verteenwoordiging in genoemde Raad van die Kiesafdeling Khomasdal.

Pursuant to sections 175 and 177 of the Electoral Consolidation Act, 1946 (Act 46 of 1946), read with section 9 of the Establishment of an Elected Coloured Council for South West Africa Ordinance, 1966 (Ordinance 29 of 1966), I hereby declare that on account of the vacation of the seat of Mr. A. J. F. Kloppers in terms of section 13(b) of the said Ordinance as a result of his failure to attend a whole ordinary session of the Elected Coloured Council for South West Africa without the special leave of the said Council, a vacancy has occurred in the representation in the said Council of the Electoral Division of Khomasdal with effect from 29 June 1978.
