Wysiging van artikel 2 van Ordonnansie 20 van 1968

1. Artikel 2 van die Ordonnansie op Myne, Bedrywe
en Minerale, 1968, word hierby gewysig —

AMENDMENT OF THE MINES, WORKS AND
MINERALS ORDINANCE, 1968 (ORDINANCE 20
OF 1968), AND REPEAL OF PROCLAMATION 42
OF 1969

of 19 August 1977, I hereby make the laws set out in the
Schedule.

SCHEDULE

Amendment of section 2 of Ordinance 20 of 1968

1. Section 2 of the Mines, Works and Minerals
Ordinance, 1968, is hereby amended —

(a) by the substitution for subsection (1) of the fol-
lowing subsection:

“(1) The right of prospecting and mining for
and disposing of precious and base minerals”

(b) deur subartikel (2) te skrap.

Wysiging van artikel 71 van Ordonnansie 20 van 1968

2. Artikel 71 van die Ordonnansie op Myne, Bedrywe en Minerale, 1968, word hierby gewysig deur die volgende voorbehoudsbepaling by subartikel (1) te voeg:

“Met dien verstande dat, indien sodanige grond ’n naturelleservaar is, die volle bedrag van sodanige gelde aan die eienaar oorbetaal word.”.

Herroeping van Proklamasie 42 van 1969

3. Proklamasie 42 van 1969 van die Staatspresident van die Republiek van Suid-Afrika word hierby herroep.

Voorbehoude

4. ’n Vergunning om te prospekter of ander reg wat kragtens of uit hoofde van die bepalings van genoemde Proklamasie 42 van 1969 verleen of verkry is en wat by die inwerkingtreeding van hierdie Proklamasie van krag is, bly van krag asof artikels 1 en 3 nie ingevoer is nie.

Kort titel

5. Hierdie Proklamasie heet die Proklamasie op Mineraleregte, 1978.

(b) by the deletion of subsection (2).

Amendment of section 71 of Ordinance 20 of 1968

2. Section 71 of the Mines, Works and Minerals Ordinance, 1968, is hereby amended by the addition to subsection (1) of the following proviso:

“Provided that, if such land is a native reserve, the full amount of such fees shall be paid over to the owner.”.

Repeal of Proclamation 42 of 1969

3. Proclamation 42 of 1969 of the State President of the Republic of South Africa is hereby repealed.

Savings

4. Any permission to prospect or other right granted or acquired under or by virtue of the provisions of the said Proclamation 42 of 1969 and of force at the coming into operation of this Proclamation, shall continue to be of force as if sections 1 and 3 had not been introduced.

Short title

5. This Proclamation shall be called the Mineral Rights Proclamation, 1978.
