EVANGELICAL LUTHERAN CHURCH,  
SWAKOPMUND, SOUTH WEST AFRICA

Under the powers vested in me by section 10(1) of the National Monuments Act, 1969 (Act 28 of 1969), I hereby declare the Evangelical Lutheran church building, situate on Erf 183, Swakopmund, South West Africa, to be a national monument.

#### DESCRIPTION

The historic Evangelical Lutheran church building, situate on certain Erf 183 (formerly Parzelle 70/7 Sheet 5), situate in the municipality and district of Swakopmund, and measuring five thousand (5 000) square metres.  
Deed of Transfer 1259/1967, dated 22 August 1967

#### HISTORICAL AND ARCHITECTURAL INTEREST

This church building, in the neo-Rococo style, was designed by Government Architect Ertl in 1909 and erected by F. H. Schmidt, a firm of building contractors. The church was consecrated on 7 January 1912.
