

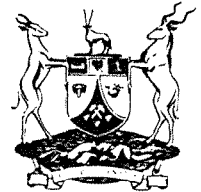

FIXING OF DATE REFERRED TO IN SECTION  
22(4) OF THE GENERAL LAW AMENDMENT  
ACT, 1967 (ACT 102 OF 1967), AS AMENDED BY  
PROCLAMATION AG. 73 OF 1978

Under the powers vested in me by subsection (4) of section 22 of the General Law Amendment Act, 1967 (Act 102 of 1967), I hereby fix 15 November 1978 as the date as from which the holder of a licence issued under the laws relating to the sale of liquor, may sell liquor as contemplated in that subsection.
