Die Administrateur-generaal het kragtens artikel 32(4) van die Proklamasie op Inboorlinge in Stedelike Gebiede, 1951 (Proklamasie 56 van 1951), gelees met artikel 3 van die Wet op die Administrasie van Naturellesake in Suidwes-Afrika, 1954 (Wet 56 van 1954), en artikel 2 van die Proklamasie op die Oordrag van Uitvoerende Gesag, 1977 (Proklamasie AG. 3 van 1977), die wysiging van die Inboorlinglokasieregulasies wat deur die Munisipaliteit van Tsumeb aanvaar is en in die Bylae vervat is, goedgekeur.

The Administrator-General has under section 32(4) of the Natives (Urban Areas) Proclamation, 1951 (Proclamation 56 of 1951), read with section 3 of the South West Africa Native Affairs Administration Act, 1954 (Act 56 of 1954), and section 2 of the Executive Powers Transfer Proclamation, 1977 (Proclamation AG. 3 of 1977), approved the amendment of the Native Location Regulations adopted by the Municipality of Tsumeb and set out in the Schedule.

SCHEDULE

MUNICIPALITY OF TSUMEB  
AMENDMENT OF NATIVE LOCATION  
REGULATIONS

1. Regulation 8 of Chapter II of the Native Location Regulations published by Government Notice 325 of 1 November 1952, as amended, is hereby amended by the substitution in subregulation (2) for the amount "50c", wherever it occurs, of the amount "R1,50".

(11) Nuwe enkelkwartiere, per persoon	5,00”;

(b) deur tarief C in genoemde subregulasie (1) deur die volgende tarief te vervang:

“C. *Huur van gemeenskapsaal, per dag of gedeelte van 'n dag.*

(1) Private persone	R15,00
(2) Kerke, skole, sport en liefdadigheid	10,00
(3) Toergroepe	50,00”;

en

(c) deur tarief E in genoemde subregulasie (1) deur die volgende tarief te vervang:

“E. *Loseerderspermit per maand of gedeelte van 'n maand:* R1,50”.

2. Regulation 14 of the said Native Location Regulations is hereby amended —

(a) by the substitution for tariff B in subregulation (1) of the following tariff:

“B. *Rental for houses, per month or part of a month.*

(1) Six-roomed houses NE 52/4	R12,00
(2) Five-roomed houses NE 52/6	11,00
(3) Four-roomed houses NE 52/7	9,00
(4) Four-roomed houses NE 51/104	8,00
(5) Four-roomed houses NE 51/6	5,00
(6) Two-roomed houses	2,75
(7) Single quarters, per person	2,00
(8) A. Type houses (2 bedrooms)	31,10
(9) B. Type houses (3 bedrooms)	37,60
(10) C. Type houses (2 bedrooms)	5,00”;
(11) New single quarters, per person	5,00”;

(b) by the substitution for tariff C in the said subregulation (1) of the following tariff:

“C. *Rental for communal hall, per day or part of a day.*

(1) Private persons	R15,00
(2) Churches, schools, sport and charity	10,00
(3) Touring groups	50,00”;

and

(c) by the substitution for tariff E in the said subregulation (1) of the following tariff:

“E. *Lodger's permit, per month or part of a month:* R1,50”.
