1. Regulation 19 promulgated by Government Notice 1912 of 12 October 1973 is hereby amended by the substitution in paragraph (e) of subregulation (1) for the expression "1 September" and the expression "24 March" of the expression "1 October" and the expression "18 March", respectively.

Amendment of regulation 26 promulgated by Government Notice 1912 of 1973, as amended by Government Notices 1597 of 1974, 1252 of 1975, 2507 of 1976, R.825 of 1977 and AG.8 of 1978

2. Regulation 26 promulgated by Government Notice 1912 of 12 October 1973 is hereby amended —

- (a) by the substitution in subregulation (1) for the expression "25 March" and the expression "31 August" of the expression "19 March" and the expression "30 September", respectively; and
- (b) by the substitution in subregulation (3) for the expression "24 March" of the expression "18 March".
