ORDINANCE, 1979: PROMULGATION OF

The Administrator-General has assented, in terms of section 27 of the South-West Africa Constitution Act, 1968 (Act 39 of 1968), to the following Ordinance which is hereby published for general information in terms of section 29 of the said Act:—

No. 15 of 1979 SECOND EDUCATION AMENDMENT ORDINANCE, 1979

ORDINANCE

To amend the Education Ordinance, 1975, in regard to the period of probation for which a person is appointed to the education personnel; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:—

Amendment of section 53
of Ordinance 21 of 1975.

1. Section 53 of the Education Ordinance, 1975, is hereby amended by the addition to subsection (2) of the following proviso:

“Provided that the period of probation for which a person is so appointed shall be extended by the number of days leave taken by him during the said period of probation or any extension thereof.”.

Short title and com-
mencement.

2. This Ordinance shall be called the Second Education Amendment Ordinance, 1979, and shall be deemed to have come into operation on 1 January 1979.

ORDONNANSIE

Tot wysiging van die Onderwysordonnansie, 1975, betreffende die proeftyd waarvoor 'n persoon in die onderwyspersoneel aangestel word; en om voorsiening te maak vir verbandhoudende aangeleenthede.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN SOOS VOLG:-

1. Artikel 53 van die Onderwysordonnansie, 1975, word hierby gewysig deur die volgende voorbehoudsbepaling by subartikel (2) te voeg:

Wysiging van artikel 53 van Ordonnansie 21 van 1975.

“Met dien verstande dat die proeftyd waarvoor 'n persoon aldus aangestel word, verleng word met die getal dae verlof wat hy gedurende bedoelde proeftyd of enige verlenging daarvan geneem het.”.

2. Hierdie Ordonnansie heet die Tweede Onderwyswysigingsordonnansie, 1979, en word geag op 1 Januarie 1979 in werking te getree het.
