

PROMULGATION OF ACT OF NATIONAL ASSEMBLY

The following Act, which has been adopted by the National Assembly of South West Africa and signed by the Administrator-General in terms of the National Assembly Proclamation, 1979 (Proclamation AG. 21 of 1979) is hereby published in terms of section 19 of that Proclamation:—

AN ACT RELATING TO MONUMENTS

DATED 20 AUGUST

ACT

THIRTY-EIGHTH LAW

ACT NO. 7 OF 1979 AUTHORIZED & ASSENTED TO BY THE NATIONAL ASSEMBLY ON 20 AUGUST 1979, AND APPROVED & PUBLISHED IN THE GOVERNMENT GAZETTE ON 21 AUGUST 1979.

To provide for the application of the National Monuments Amendment Act, 1979, in South West Africa, and for matters connected therewith.

BE IT ENACTED by the National Assembly of South West Africa, as follows:

Application of Act 35 of 1979 in South West Africa.

Short title and commencement

1. The National Monuments Amendment Act, 1979, except sections 14 and 15 thereof, shall apply in the territory of South West Africa.

2. This Act shall be called the National Monuments Act Amendment Act, 1979, and shall be deemed to have come into operation on 11 April 1979.
