ADVERTEER IN DIE OFFISIELLE KOERANT VAN SUIDWES-AFRIKA

1. The *Official Gazette* Extraordinary containing advertisements is published on every Friday of each month; if those days fall on a Public Holiday, the *Official Gazette* is published on the preceding Thursday.

2.
