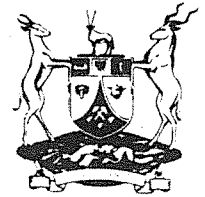

**AMENDMENT OF REGULATIONS MADE
 UNDER THE WATER ACT, 1956 (ACT 54 OF
 1956)**

Kragtens die bevoegdheid my verleen by artikel 180(3) van die Waterwet, 1956 (Wet 54 van 1956) vaardig ek hierby die regulasies uit wat in die Bylae vervat is.

Under the powers vested in me by section 180(3) of the Water Act, 1956 (Act 54 of 1956) I hereby make the regulations set out in the Schedule.

BYLAE

SCHEDULE

Wysiging van regulasie 3 afgekondig by Goewermentskennisgewing R 1277 van 1971 soos gewysig deur Goewermentskennisgewing R 875 van 1975.

Amendment of regulation 3 promulgated by Government Notice R 1277 of 1971, as amended by Government Notice R 875 of 1975.

1. Regulasie 3 van Goewermentskennisgewing R 1277 van 1971 word hierby herroep en vervang met die volgende regulasie:

1. Regulation 3 of Government Notice R 1277 of 1971 is hereby deleted and the following regulation substituted therefor:

“3. Die Raad bestaan uit die Direkteur wat Voor-sitter daarvan is en hoogstens tien maar minstens agt ander lede wat deur die Administrateur-generaal aangestel word en van wie —

een iemand met kennis van waterboukunde is;

een ’n beampte van die Direktoraat van Landbou en Bosbou is;

een iemand is om die Munisipale Vereniging van Suidwes-Afrika te verteenwoordig;

een iemand met kennis van boerdery is;

een iemand met kennis van mynwese en nywerheids-wese is; en

die ander lede persone is wat betrokke is by die algemene ontwikkeling van die land.”

Wysiging van regulasie 9 afgekondig by Goewermentskennisgewing R 1277 van 1971, soos gewysig deur Goewermentskennisgewing R 875 van 1975.

2. Regulasie 9 van Goewermentskennisgewing R 1277 van 1971 word hierby herroep en vervang deur die volgende regulasies:

“9. (1) Die kworum op ’n vergadering van die Raad is, in die geval waar die Raad uit nege lede bestaan, vyf lede daarvan waarvan twee by die algemene ontwikkeling van die land betrokke is, of in die geval waar die Raad uit elf lede bestaan, sewe lede daarvan waarvan drie aldus betrokke is.

(2) Die beslissing van ’n meerderheid van die lede wat op ’n vergadering van die Raad aanwesig is, maak ’n besluit van die Raad uit, en by ’n staking van stemme betreffende enige saak, het die Voorsitter ’n beslissende stem benewens sy beraadslagende stem.”

“3. The Board shall consist of the Director, who shall be the Chairman thereof and not more than ten and not less than eight other members appointed by the Administrator General of whom —

one shall be a person having a knowledge of hydraulic engineering;

one shall be an officer of the Directorate of Agriculture and Forestry;

one shall be a person to represent the Municipal Association of South West Africa;

one shall be a person having knowledge of farming;

one shall be a person having a knowledge of mining and industry; and

the balance of the members shall be persons who are involved in the general development of the country.”

Amendment of regulation 9 promulgated by Government Notice R 1277 of 1971 as amended by Government Notice R 875 of 1975.

2. Regulation 9 of Government Notice R 1277 of 1971 is hereby deleted and the following regulations substituted therefor:

“9. (1) A quorum on a meeting of the Board shall be in the case where the Board consists of nine members, five members thereof of whom two shall be involved in the general development of the country or if the Board consists of eleven members, seven members thereof of whom three shall be involved in the general development of the country.

(2) The decision of a majority of the members present at a meeting of the Board shall constitute a decision of the Board, and in the event of an equality of votes on any matter the Chairman shall have a casting vote in addition to his deliberative vote.”
