Wysiging van artikel 26A van Ordonnansie 1 van 1926, soos ingevoeg deur artikel 1 van Ordonnansie 20 van 1970

Amendment of section 26A of Ordinance 1 of 1926, as inserted by section 1 of Ordinance 20 of 1970

1. Artikel 26A van die Finansie en Ouditeer Ordonnansie, 1926, word hierby gewysig deur in subartikel (3) die woorde "Verdediging en" te skrap.

1. Section 26A of the Finance and Audit Ordinance, 1926, is hereby amended by the deletion in subsection (3) of the words "Defence and".

Wysiging van regulasie 3 van die regulasies afgekondig by Goewermentskennisgewing 132 van 1970, soos gewysig deur Goewermentskennisgewing 38 van 1975

Amendment of regulation 3 of the regulations published by Government Notice 132 of 1970, as amended by Government Notice 38 of 1975

2. Regulasie 3 van die regulasies afgekondig by Goewermentskennisgewing 132 van 18 September 1970 word hierby gewysig deur in subregulasie (1) die woorde "Verdediging en" te skrap.

2. Regulation 3 of the regulations published by Government Notice 132 of 18 September 1970 is hereby amended by the deletion in subregulation (1) of the words "Defence and".

Kort titel en inwerkingtreding

Short title and commencement

3. Hierdie Proklamasie heet die Wysigingsproklamasie op Finansies en Ouditering, 1980, en word geag op 1 April 1980 in werking te getree het.

3. This Proclamation shall be called the Finance and Audit Amendment Proclamation, 1980, and shall be deemed to have come into operation on 1 April 1980.
