PORTION OF DISTRICT ROAD 2107 DISTRICT OF WINDHOEK

Van 'n punt op die gemeenskaplike grens van Ge-
deelte 65 van Nubuamis 37 en die Restant van Ge-
deelte B van Nubuamis 37 oor laasgenoemde plaas en
die plaas Ongos 38 tot 'n punt op die noordelike grens
van laasgenoemde plaas (B-C-D op inlas van skets-
kaart P1083).

From a point on the common boundary of Portion 65
of Nubuamis 37 and the Remainder of Portion B of Nu-
buamis 37 across the last-mentioned farm and the farm
Ongos 38 to a point on the northern boundary of the
last-mentioned farm (B-C-D on insert of sketch-plan
P1083).
