APPOINTMENT OF COMMISSION OF INQUIRY
INTO HEALTH SERVICES IN SOUTH WEST
AFRICAAANSTELLING VAN KOMMISSIE VAN
ONDERSOEK NA GESONDHEIDSDIENSTE IN
SUIDWES-AFRIKA

It is hereby notified for general information that the Administrator-general has been pleased to appoint a Commission of Inquiry into Health Services in South-West Africa with the following terms of reference:

Hierby word vir algemene inligting bekend gemaak dat dit die Administrateur-generaal behaag het om 'n Kommissie van Onderzoek na Gesondheidsdienste in Suidwes-Afrika aan te stel met die volgende opdrag:

1. To inquire into and to make recommendations regarding the establishment and the provision of an efficient health service for all the inhabitants of South-West Africa.
2. In view of the inquiry the Commission is requested to:
 - 2.1 Determine in particular the needs of the various communities relating to the provision of health services to them and to pay attention to the solutions thereto.
 - 2.2 Pay special attention to the existing services, facilities and resources in this regard and to the present as well as the possible future utilisation thereof.
 - 2.3 Pay attention to the services, facilities and resources which will be needed to provide an efficient health service to the various communities.
 - 2.4 Pay attention to existing Health legislation in the Territory of South-West Africa with a view to adjustments and new legislation in this regard, within the context of the constitutional framework in South-West Africa.
3. The Commission is authorized to investigate any other matters which according in its opinion may be connected herewith including the financial implications and the manner in which any appropriation of funds shall be made.

1. Om ondersoek in te stel na en aanbevelings te doen oor die instelling en lewering van 'n doeltreffende gesondheidsdiens vir al die inwoners van Suidwes-Afrika.
2. Met die oog op die ondersoek word die Kommissie versoek om:
 - 2.1 In die besonder die verskillende gemeenskappe se behoeftes met betrekking tot die lewering aan hulle van gesondheidsdienste te bepaal en aandag te skenk aan die oplossings daarvan.
 - 2.2 Besondere aandag te skenk aan die bestaande dienste, fasiliteite en hulpbronne in bogenoemde verband en die huidige en moontlike toekomstige aanwending daarvan.
 - 2.3 Aandag te skenk aan die dienste, fasiliteite en hulpbronne wat nodig sal wees om aan die verskillende gemeenskappe 'n doeltreffende gesondheidsdiens te lewer.
 - 2.4 Aandag te skenk aan die bestaande Gesondheidswetgewing in die gebied Suidwes-Afrika met die oog op aanpassings en nuwe wetgewing in hierdie verband, binne die raamwerk van die konstitusionele opset in Suidwes-Afrika.
3. Die Kommissie word gemagtig om enigiets verder te ondersoek wat na sy oordeel hiermee mag saamhang insluitende die finansiële implikasies en die wyse waarop enige bewilliging van fondse moet geskied.
