**PROMULGATION OF ACT OF NATIONAL
 ASSEMBLY**

**AFKONDIGING VAN WET VAN NASIONALE
 VERGADERING**

The following Act, which has been adopted by the National Assembly of South West Africa and signed by the Administrator-General in terms of the National Assembly Proclamation, 1979 (Proclamation AG. 21 of 1979), is hereby published in terms of section 19 of that Proclamation:—

Die volgende Wet, wat ingevolge die Proklamasie op die Nasionale Vergadering, 1979 (Proklamasie AG. 21 van 1979), deur die Nasionale Vergadering van Suidwes-Afrika aangeneem en deur die Administrateur-generaal onderteken is, word hierby afgekondig ingevolge artikel 19 van daardie Proklamasie:—

Act No. 20, 1981 SECURITY DISTRICTS AMENDMENT ACT, 1981

(English text signed by the Administrator-General on 10 December 1981)

ACT

To amend the Security Districts Proclamation, 1977, so as to provide for the questioning in relation to certain offences of persons who are detained under an order issued in terms of section 5bis of the said Proclamation.

BE IT ENACTED by the National Assembly of South West Africa, as follows:—

Amendment of section 5bis of Proclamation AG. 9 of 1977, as inserted by section 2 of Proclamation AG. 27 of 1979 and amended by section 1 of Proclamation AG. 11 of 1980.

1. Section 5bis of the Security Districts Proclamation, 1977, is hereby amended by the addition of the following subsection:

“(4) The conditions referred to in paragraph (c) of subsection (1) may include a condition that any person for whose further detention an order has been issued under the said subsection (1) may at any time be questioned by a member of the security forces in relation to any offence or intended offence referred to in section 4(2).”

Short title.

2. This Act shall be called the Security Districts Amendment Act, 1981.

WYSIGINGSWET OP VEILIGHEIDSDISTRIKTE, 1981 Wet No. 20, 1981

(Engelse teks deur die Administrateur-generaal onderteken op 10 Desember 1981)

WET

Tot wysiging van die Proklamasie op Veiligheidsdistrikte, 1977, ten einde voorsiening te maak vir die ondervraging met betrekking tot sekere misdrywe van persone wat kragtens 'n bevel uitgereik ingevolge artikel 5bis van genoemde Proklamasie aangehou word.

DAAR WORD BEPAAL deur die Nasionale Vergadering van Suidwes-Afrika, soos volg:—

1. Artikel 5bis van die Proklamasie op Veiligheidsdistrikte, 1977, word hierby gewysig deur die volgende subartikel by te voeg:

“ (4) Die voorwaardes in paragraaf (c) van subartikel (1) bedoel, kan 'n voorwaarde insluit dat 'n persoon vir wie se verdere aanhouding 'n bevel kragtens genoemde subartikel (1) uitgereik is te eniger tyd deur 'n lid van die veiligheids-magte ondervra kan word met betrekking tot 'n misdryf of voorgenome misdryf in artikel 4(2) bedoel.”

2. Hierdie Wet heet die Wysigingswet op Veiligheidsdistrikte, 1981.

Wysiging van artikel 5bis van Proklamasie AG. 9 van 1977, soos ingevoeg deur artikel 2 van Proklamasie AG. 27 van 1979 en gewysig deur artikel 1 van Proklamasie AG. 11 van 1980.
