MUNISIPALITEIT VAN WINDHOEK : WYSIGING VAN PERSONEELREGULASIES

MUNICIPALITY OF WINDHOEK : AMENDMENT OF STAFF REGULATIONS

Die Uitvoerende Komitee van die Blankes het kragtens artikel 243 van die Municipale Ordonnansie 1963 (Ordonnansie 13 van 1963) die regulasie goedgekeur wat in die Bylae vervat en deur die Munisipaliteit van Windhoek gemaak is om die Personeelregulasies, afgekondig by Goewermentskennisgewing 72 van 3 September 1981, te wysig.

The Executive Committee of the Whites has under section 243 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), approved the regulation set out in the Schedule and made by the Municipality of Windhoek to amend the Staff Regulations, promulgated by Government Notice 72 of 3 September 1981.

BYLAE

Regulasie 32 word hierby gewysig —

(a) deur subregulasie (1) deur die volgende subregulasie te vervang:

"(1) (a) 'n Vervoertoelaag, bereken teen R0,2856 per km of gedeelte van 'n km wat werklik in die diens van die Raad afgelê is, is aan 'n werknemer, uitgesonderd 'n werknemer in paragraaf (b) bedoel, betaalbaar wat sy private motorvoertuig met die toestemming van die Bestuurskomitee gegee is met die goedkeuring van die Raad binne die munisipale gebied in die uitvoering van sy pligte gebruik het.

(b) 'n Brandstof- en lopende kostetoe-laag, bereken teen R0,1014 per km of gedeelte van 'n km wat werklik in die diens van die Raad afgelê is, is, benewens enige ander toelaag, op aanvraag betaalbaar aan 'n werknemer wat die betrokke motorvoertuig aangeskaf het met 'n lening wat kragtens artikel 241(2)(b)(iv) van die Ordonnansie toegeken is."; en

1. Koste

3. Minimum koste

NOTES:

1. Charges

Charges are levied on a ton or cubic metre, whichever yields the higher overall charge.

2. Ton

A ton shall mean 1 000 kg.

3. Minimum charges

The minimum charge for services specified is as for one ton, one cubic metre or one kilolitre. Fractions of a ton, cubic metre or kilolitre on consignments exceeding one ton, one cubic metre or one kilolitre are levelled up to the next higher 100 kilograms, 100 cubic decimetres or 100 litres.

4. Maximum mass of packages
