1. Artikel 243 van die Municipale Ordonnansie 1963 word hierby gewysig —

(a) deur die volgende subartikel na subartikel
(1) in te voeg:

**AMENDMENT OF THE MUNICIPAL ORDINANCE,
1963 (ORDINANCE 13 OF 1963)**

ANNEXURE

*Amendment of section 243 of Ordinance 13 of
1963*

1. Section 243 of the Municipal Ordinance, 1963, is hereby amended —

(a) by the insertion after subsection (1) of the following subsection:

"(1)*bis* Die bepalings van subartikel (1) is nie van toepassing nie op enige regulasies deur die raad kragtens artikel 242(38) aangeneem ter voldoening aan 'n advies van die Sekretaris van Waterwese aan die raad dat dit nodig is om maatreëls te tref ten einde water te bespaar."; en

- (b) deur in subartikel (2) die woord "As" waar dit die eerste keer voorkom deur die woorde "As die raad enige regulasies aangeneem het waarop die bepalings van subartikel (1) nie van toepassing is nie of as" te vervang.

Kort titel

2. Hierdie Proklamasie heet die Municipale Wysigingsproklamasie, 1982.

"(1)*bis* The provisions of subsection (1) shall not apply to any regulations passed by the council under section 242(38) in compliance with any advice by the Secretary for Water Affairs to the council that it is necessary to take measures in order to save water."; and

- (b) by the substitution for the word "If" in subsection (2) of the words "If the council has passed any regulations to which the provisions of subsection (1) do not apply or if".

Short title

2. This Proclamation shall be called the Municipal Amendment Proclamation, 1982.
