Die volgende Wet, wat ingevolge die Proklamasie op die Nasionale Vergadering, 1979 (Proklamasie AG. 21 van 1979), deur die Nasionale Vergadering van Suidwes-Afrika aangeneem en deur die Administrateur-generaal onderteken is, word hierby afgekondig ingevolge artikel 19 van daardie Proklamasie:—

The following Act, which has been adopted by the National Assembly of South West Africa and signed by the Administrator-General in terms of the National Assembly Proclamation, 1979 (Proclamation AG. 21 of 1979), is hereby published in terms of section 19 of that Proclamation:—

WET

Om voorsiening te maak vir die toepassing van die Ordonnansie op Adverteer langs, en Toebou van Paaie, 1960, in Oos-Caprivi en vir die toepassing van sekere wysigings daarvan in Owambo en Kavango; om voorsiening te maak vir die toepassing van die Ordonnansie op Paaie, 1972, en die regulasies daarkragtens gemaak in Oos-Caprivi en om die toepassing daarvan in Owambo en Kavango uit te brei; om voorsiening te maak vir die toepassing van die Wysigingsordonnansie op Paaie, 1980, in Damaraland; en om voorsiening te maak vir verbandhoudende aangeleenthede.

DAAR WORD BEPAAL deur die Nasionale Vergadering van Suidwes-Afrika, soos volg:-

Toepassing van Ordonnansie 30 van 1960 in Oos-Caprivi en van sekere wysigings daarvan in Owambo en Kavango.

1. (1) Die Ordonnansie op Adverteer langs, en Toebou van Paaie, 1960 (Ordonnansie 30 van 1960), en alle wysigings daarvan is ook van toepassing in Oos-Caprivi soos omskryf in die Bylae by Goewermentskennisgewing 2429 van 1972.

(2) Alle wysigings van die Ordonnansie op Adverteer langs, en Toebou van Paaie, 1960 (Ordonnansie 30 van 1960), is, ondanks andersluidende wetsbepalings, ook van toepassing in —

(a) Owambo soos omskryf in Bylae C by Goewermentskennisgewing 2428 van 1972 soos gewysig by Goewermentskennisgewing 165 van 1977;

(b) Kavango, bestaande uit Gebied 1 omskryf in Bylae D by Goewermentskennisgewing 2428 van 1972.

**APPLICATION OF LAWS RELATING TO ROADS

Act No. 5, 1982

*(English text signed by the Administrator-General on 30
March 1982)*

ACT

To provide for the application of the Advertising on Roads and Ribbon Development Ordinance, 1960, in Eastern Caprivi and for the application of certain amendments thereof in Owambo and Kavango; to provide for the application of the Roads Ordinance, 1972, and the regulations made thereunder in Eastern Caprivi and to extend the application thereof in Owambo and Kavango; to provide for the application of the Roads Amendment Ordinance, 1980, in Damaraland; and to provide for incidental matters.

BE IT ENACTED by the National Assembly of South West Africa, as follows:-

1. (1) The Advertising on Roads and Ribbon Development Ordinance, 1960 (Ordinance 30 of 1960), as well as all amendments thereof shall apply also in Eastern Caprivi as defined in the Schedule to Government Notice 2429 of 1972.

Application of Ordinance 30 of 1960 in Eastern Caprivi and of certain amendments thereof in Owambo and Kavango.

(2) All amendments of the Advertising on Roads and Ribbon Development Ordinance, 1960 (Ordinance 30 of 1960), shall, notwithstanding anything to the contrary contained in any law, apply also in —

- (a) Owambo as defined in Schedule C to Government Notice 2428 of 1972 as amended by Government Notice 165 of 1977;**
- (b) Kavango, consisting of Area 1 defined in Schedule D to Government Notice 2428 of 1972.**

2. (1) Die Ordonnansie op Paaie, 1972 (Ordonnansie 17 van 1972), en alle wysigings daarvan en alle regulasies daarkragtens gemaak, is ook van toepassing in Oos-Caprivi soos omskryf in die Bylae by Goewermentskennisgewing 2429 van 1972.

(2) Die Ordonnansie op Paaie, 1972 (Ordonnansie 17 van 1972), en alle wysigings daarvan en alle regulasies daarkragtens gemaak, word hierby ook in —

(a) Owambo soos omskryf in Bylae C by Goewermentskennisgewing 2428 van 1972 soos gewysig by Goewermentskennisgewing 165 van 1977;

(b) Kavango, bestaande uit Gebied 1 omskryf in Bylae D by Goewermentskennisgewing 2428 van 1972,

van toepassing gemaak vir sover dit nie alreeds in genoemde Owambo en Kavango van toepassing is nie.

Toepassing van Ordonnansie 6 van 1980 in Damaraland.

3. Die Wysigingsordonnansie op Paaie, 1980 (Ordonnansie 6 van 1980), is ook van toepassing in Damaraland soos omskryf in Bylae B by Goewermentskennisgewing 2428 van 1972.

Herroeping van wette.

4. (1) Behoudens die bepalings van subartikel (2), word die wette —

(a) in Bylae 1 vermeld, hierby herroep vir sover bedoelde wette nog in Oos-Caprivi soos omskryf in die Bylae by Goewermentskennisgewing 2429 van 1972 van krag is;

(b) in Bylae 2 vermeld, hierby herroep vir sover bedoelde wette nog in —

(i) Owambo soos omskryf in Bylae C by Goewermentskennisgewing 2428 van 1972 soos gewysig by Goewermentskennisgewing 165 van 1977;

(ii) Kavango, bestaande uit Gebied 1 omskryf in Bylae D by Goewermentskennisgewing 2428 van 1972,

van krag is.

(2) Enigiets wat kragtens of ingevolge enige bepaling van enige by subartikel (1)(b) herroepe wet gedoen is, word, indien dit nie strydig of onbestaanbaar met die bepalings van die Ordonnansie op Paaie, 1972 (Ordonnansie 17 van 1972), is nie, geag kragtens of ingevolge die ooreenstemmende bepaling van genoemde Ordonnansie gedoen te gewees het.

**APPLICATION OF LAWS RELATING TO ROADS
IN EASTERN CAPRIVI, OWAMBO, KAVANGO
AND DAMARALAND ACT, 1982**

Act No. 5, 1982

2. (1) The Roads Ordinance, 1972 (Ordinance 17 of 1972), as well as all amendments thereof and all regulations made thereunder shall apply also in Eastern Caprivi as defined in the Schedule to Government Notice 2429 of 1972.

Application of Ordinance 17 of 1972 in Eastern Caprivi, Owambo and Kavango.

(2) The Roads Ordinance, 1972 (Ordinance 17 of 1972), as well as all amendments thereof and all regulations made thereunder are hereby made applicable also in —

(a) Owambo as defined in Schedule C to Government Notice 2428 of 1972 as amended by Government Notice 165 of 1977;

(b) Kavango, consisting of Area 1 defined in Schedule D to Government Notice 2428 of 1972,

in so far as they are not already applicable in the said Owambo and Kavango.

3. The Roads Amendment Ordinance, 1980 (Ordinance 6 of 1980), shall apply also in Damaraland as defined in Schedule B to Government Notice 2428 of 1972.

Application of Ordinance 6 of 1980 in Damaraland.

4. (1) Subject to the provisions of subsection (2), the laws —

Repeal of laws.

(a) specified in Schedule 1 are hereby repealed in so far as the said laws are still in force in Eastern Caprivi as defined in the Schedule to Government Notice 2429 of 1972;

(b) specified in Schedule 2 are hereby repealed in so far as the said laws are still in force in —

(i) Owambo as defined in Schedule C to Government Notice 2428 of 1972 as amended by Government Notice 165 of 1977;

(ii) Kavango, consisting of Area 1 defined in Schedule D to Government Notice 2428 of 1972.

(2) Anything done under or in terms of any provision of any law repealed by subsection (1)(b) shall, if not contrary to or inconsistent with the provisions of the Roads Ordinance, 1972 (Ordinance 17 of 1972), be deemed to have been done under or in terms of the corresponding provision of the said Ordinance.
