PUBLICATION OF ORDINANCE OF LEGISLATIVE ASSEMBLY OF THE WHITES

The following Ordinance assented to by the Administrator-General in terms of the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), is hereby published in terms of section 16 of the Representative Authority of the Whites Proclamation, 1980 (Proclamation AG. 12 of 1980):-

FINANCIAL AFFAIRS ORDINANCE, 1982.**Ordinance
No. 8 of 1982**

ORDINANCE

To provide for the transfer of unexpended moneys from the Territorial Development and Reserve Fund to the Revenue Fund of the Representative Authority of the Whites and the Central Revenue Fund, and for matters connected therewith.

BE IT ORDAINED by the Legislative Assembly of the Whites, with the consent of the Administrator-General previously obtained for the purposes of section 14(1)(a)(ii) of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), and communicated to the Assembly by the Chairman of the Assembly, as follows:-

1. Notwithstanding anything to the contrary in any law contained, all unexpended moneys credited to the accounts of the Territorial Development and Reserve Fund, established by section 2(1) of the Territorial Development and Reserve Fund Ordinance, 1944 (Ordinance 13 of 1944), shall hereby be withdrawn from the said fund and —

Transfer of unexpended moneys from the Territorial Development and Reserve Fund to the Revenue Fund of the Representative Authority of the Whites and the Central Revenue Fund.

- (a) an amount of R7 167 878,32 thereof paid into the Revenue Fund of the Representative Authority of the Whites; and
- (b) an amount of R14 670 375,71 thereof paid into the Central Revenue Fund.

2. The laws specified in the Schedule are hereby repealed to the extent set out in the third column thereof.

Repeal of laws.

3. This Ordinance shall be called the Financial Affairs Ordinance, 1982.
