**Ordinance No. 1 ADDITIONAL APPROPRIATION ORDINANCE 1983
of 1983**

(Assented to by the Administrator-general on 25 March 1983 — Afrikaans text signed)

ORDINANCE

To appropriate an additional amount for the administration of the affairs of the Namas during the financial year ending 31 March 1983.

BE IT ORDAINED by the Legislative Assembly of the Namas, as follows:-

Appropriation of Additional amount of R2 404 750 for administration of affairs of Namas.

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), and the State Finance Act, 1982 (Act 1 of 1982), the additional amounts of money set out in the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Namas, for the administration of the affairs of the Namas during the financial year ending 31 March 1983.

Short title.

2. This Ordinance shall be called the Additional Appropriation Ordinance, 1983.
