ADDITIONAL APPROPRIATION ORDINANCE 1983

(Assented to by the Administrator-general on 29 March 1983 — English text signed)

ORDINANCE

To appropriate an additional amount of money for the administration of the affairs of the Tswanas during the financial year ending 31 March 1983.

BE IT ORDAINED by the Legislative Assembly of the Tswanas, as follows:-

Appropriation of additional amount of R776 970 for administration of affairs of Tswanas.

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), and the State Finance Act, 1982 (Act 1 of 1982), the additional amounts of money set out in the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Tswanas, for the administration of the affairs of the Tswanas during the financial year ending 31 March 1983.

Short title

2. This Ordinance shall be called the Additional Appropriation Ordinance (1982-'83), 1983.
