The Administrator-General has under section 40 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970), further amended the regulations published under Government Notice R. 1830 of 1970, as amended, and applied to the peri-urban area of Lüderitz by Government Notice 6 of 1975, as set out in the Schedule with effect from 1 August 1983.

## SCHEDULE

Annexure A of Chapter 10 is hereby amended -

“(a) Basic charge

The following basic charge shall be payable monthly by every consumer where water connections are available, irrespective of whether water has been consumed or not:

- (i) for water connections up to a diameter of 20 millimetres ..... R6,10
- (ii) for water connections with a diameter of more than 20 millimetres ..... R30,50.”; and
