1984)**(Afrikaans text signed)***ORDINANCE****To appropriate an amount of money for the administration  
of the affairs of the Coloureds during the financial year  
ending 31 March 1985.**BE IT ORDAINED by the Legislative Assembly of the  
Coloureds, as follows:-

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), and the State Finance Act, 1982 (Act 1 of 1982), the amounts of money set out in the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Coloureds, for the administration of the affairs of the Coloureds during the financial year ending 31 March 1985.

2. This Ordinance shall be called the Appropriation Ordinance, 1984.
