Kragtens artikel 47(6), saamgelees met artikel 56(1) van die Ordonnansie op Myne, Bedrywe en Minerale 1968 (Ordonnansie 20 van 1968), word die myngebied bekend as Trotzig No. 1, geleë naby die Doros Berge in die distrik Outjo, registrasie-afdeling A, groot 123,4632 hektaar en gehou kragtens akte van oordrag 2/1979 deur Dinah Clare Davis hierby verbeurd verklaar weens die versuim van die eienaar om die myngebiedgelde verskuldig ingevolge artikel 47(1), die boete verskuldig in terme van artikel 47(4) en die koste van publikasie van die eiskennisgewing onder dekking van Algemene Kennisgewing 47 van 1986 van 1 Mei 1986, ingevolge artikel 47(5)(c) van genoemde Ordonnansie, binne dertig dae na sodanige publikasie te betaal.

Under section 47(6), read with section 56(1) of the Mines, Works and Minerals Ordinance, 1968 (Ordinance 20 of 1968), the mining area known as Trotzig No. 1, situated near the Doros Mountains in the district of Outjo, registration division A, measuring 123,4632 hectares and held by Dinah Clare Davis under Deed of Transfer 2/1979, is hereby declared forfeited, due to the failure of the owner to pay the mining area fees payable in terms of section 47(1), the penalty payable in terms of section 47(4) and the cost of publication of the notice of demand under cover of General Notice 47 of 1986 of 1 May 1986, in terms of section 47(5)(c) of the said Ordinance, within thirty days from the date of such publication.

It is hereby made known for general information that the Cabinet has, under section 66 of the Water Act, 1956 (Act 54 of 1956), and with effect from 1 September 1986 -

- (a) 'n jaarlikse belasting van R33,50 per ingelyste hektaar gehou op besproeiingspersele wat besproei kan word met water voorsien uit die Hardap Staatswaterwerk;

- (a) assessed an annual rate of R33,50 per scheduled hectare on irrigation plots which may be irrigated with water supplied from the Hardap Government Water Work;

- (b) die vorderings vir water wat voorsien word gehef het soos in Kolom II van die Bylae aangedui teenoor, in die geval van elke vordering, die naam, in Kolom I van bedoelde Bylae, van die betrokke Staatswaterwerk en ook die tipe water (wanneer toepaslik) of die uiteensetting van die doel waarvoor die water voorsien word of die hoeveelheid daarvan wat aangewend is; en
- (c) Goewermentskennisgewing AG. 128 van 1984 herroep het.

- (b) assessed the charges for water supplied as indicated in Column II of the Schedule opposite, in the case of each charge, the name, in Column I of the said Schedule, of the relative Government Water Work and also the type of water (when applicable), or the relative exposition of the purpose for which the water is supplied or the quantity thereof which has been applied; and
- (c) repealed Government Notice AG. 128 of 1984.
