30 August 1986)**(English text signed)***ORDINANCE****To appropriate an amount of money for the administration of the affairs of the Namas during the financial year ending 31 MARCH 1987.****BE IT ORDAINED** by the Legislative Assembly of the Namas, as follows:-

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), the amounts of money set out in column 1 of the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Namas, for the administration of the affairs of the Namas during the financial year ending 31 March 1987.
