**SCHEDULE****DESCRIPTION OF PROPERTY**

The Old Post Office on Erf 241, Keetmanshoop Township, situated in the municipal area of Keetmanshoop, Registration Division T, being an unregistered part of state land as described in the general town plan of Keetmanshoop, No. 353/66, dated 28 April 1967 and filed in the office of the Surveyor-General in Windhoek, as well as the portion of the said erf (excluding any erections thereon that are not part of the original building erected in 1910) of which the specific measurements are 2 840 (two thousand eight hundred and forty) square metres and which is separated from the remaining portion of Erf 241 by an existing fence south of the Old Post Office.

**BYLAE****BESKRYWING VAN EIENDOM**

Die Ou Poskantoor op Erf 241, Keetmanshoop Dorp, geleë in die munisipale gebied van Keetmanshoop, Registrasie-Afdeling T, synde 'n ongeregistreerde gedeelte staatsgrond soos aange toon op die algemene dorpsplan van Keetmanshoop, No. 353/66, gedateer 28 April 1967 en geliasseer in die kantoor van die Landmeter-generaal in Windhoek, sowel as die gedeelte van genoemde erf (met uitsluiting van enige oprigtigs daarop wat nie deel vorm van die oorspronklike gebou wat in 1910 opgerig is nie) waarvan die besondere grootte 2 840 (tweeduiseen agthonderd-en-veertig) vierkante meter is en wat deur 'n bestaande kampdraad van die oorblywende gedeelte van Erf 241 geskei word, welke kampdraad suid van die Ou Poskantoor geleë is.

AESTHETIC INTEREST

This building, erected in 1910, is of particular architectural interest. The building is in the German Colonial style. Notable features of this style in the building are the use of contrasting materials as well as finishes and forms, the symmetry, the detailing of the windows and gables and the square tower.

## ESTETIESE BELANG

Hierdie gebou, opgerig in 1910, is van besondere argitektoniese belang. Die gebou is in die Duits-koloniale styl. Uitstaande kenmerke van hierdie styl in die gebou is die gebruik van kontrasterende materiale, sowel as afwerkings en vorms, die simmetrie, die detailering van die vensters en gewels en die vierkantige toering.
