PROCEDURE FOR ADVERTISING IN THE OFFICIAL GAZETTE OF SOUTH WEST AFRICA

PROSEDURE VIR ADVERTENSIES IN DIE OFFISIËLE KOERANT VAN SUIDWES-AFRIKA

1. The *Official Gazette* Extraordinary containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, the *Official Gazette* is published on the preceding Thursday.
