CONSTITUTION OF SPECIAL COURTS FOR
HEARING INCOME TAX APPEALS AND

Under section 73 of the Income Tax Act, 1981
(Act 24 of 1981) I hereby -

- (a) abolish the special court constituted by Proclamation AG. 14 of 1982 for the territory of South West Africa;
- (b) constitute a special court A and a special court B for hearing income tax appeals as come within the terms of the said section 73; and
