PROMULGATION OF ACT OF  
NATIONAL ASSEMBLY

AFKONDIGING VAN WET VAN

The following Act, which has been adopted by the National Assembly and signed by the Administrator-General in terms of the South West Africa Legislative and Executive Authority Establishment Proclamation, 1985 (Proclamation R.101 of 1985), is hereby published in terms of section 18 of that Proclamation: —

## ACT

**To provide for the payment from revenue to the South West African Meat Board of a certain amount of money deposited in the Central Revenue Fund during the financial year 1985/86 regarding transfer duties; and to provide for incidental matters.**

BE IT ENACTED by the National Assembly, as follows:-

Payment of an amount of money from revenue to the South West African Meat Board.

1. The amount of R15 532,82 paid as transfer duties during the financial year 1985/86 by the South West African Meat Board and deposited in the Central Revenue Fund shall be paid from revenue to the said board.

Short title.

2. This Act shall be called the Finance Act, 1987.
