The following Act, which has been adopted by the National Assembly and signed by the Administrator-General in terms of the South West Africa Legislative and Executive Authority Establishment Proclamation, 1985 (Proclamation R.101 of 1985), is hereby published in terms of section 18 of that Proclamation: —

**ACT**

**To appropriate additional amounts of money for the requirements of the State in or in respect of the territory of South West Africa during the financial year ending 31 March 1988.**

*(English text signed by the Administrator-General on 24 November 1987)*

BE IT ENACTED by the National Assembly, as follows:-

Appropriation of additional amounts of money for requirements of State.

1. Subject to the provisions of the State Finance Act, 1982 (Act 1 of 1982), there is hereby appropriated for the requirements of the State in or in respect of the territory of South West Africa during the financial year ending 31 March 1988, as a charge to the Central Revenue Fund, the additional amounts of money shown in Column 1 of the Schedule.

Short title.

2. This Act shall be called the Additional Appropriation Act, 1987.
