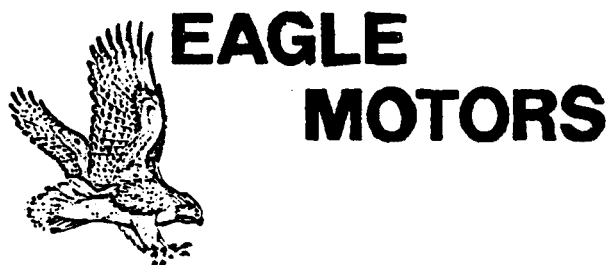

#### EXEMPTION FROM PROVISIONS OF CERTAIN SECTIONS OF THE ROAD TRAFFIC ORDINANCE, 1967

Under section 180 of the Road Traffic Ordinance, 1967 (Ordinance 30 of 1967), the Cabinet hereby exempts persons in the department of the Government Service of South West Africa mentioned in Column 1 of the Schedule, in respect of the motor vehicles with registration marks and numbers mentioned in Column 2 of the Schedule, from the provisions of the sections of the said Ordinance mentioned in Column 3 of the Schedule, in respect of the areas or places mentioned in Column 4 of the Schedule, provided that and as long as a disc bearing the number mentioned in Column 5 of the Schedule, and issued by the Secretary for Transport, is being displayed on the windscreen of the motor vehicle concerned.
