No. 2 of 1988**

ORDINANCE

To appropriate an amount of money for the administration of the affairs of the Namas during the financial year ending 31 March 1989.

BE IT ORDAINED by the Legislative Assembly of the Namas, as follows:-

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), the amounts of money set out in column 1 of the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Namas, for the administration of the affairs of the Namas during the financial year ending 31 March 1989.
