AMENDMENT OF THE REGULATIONS MADE UNDER THE STATUTORY INSTITUTIONS PENSIONS ACT, 1980

The Cabinet has under section 13 of the Statutory Institutions Pensions Act, 1980 (Act 3 of 1980), further amended the regulations promulgated by Government Notice AG. 76 of 1980 as set out in the Schedule.

SCHEDULE

1. Regulation 3 is hereby amended by the substitution in paragraph (a) of subregulation (2) for the expression "3,1" of the expression "3".

BYLAE

1. Regulasie 3 word hierby gewysig deur in paragraaf (a) van subregulasie (2) die uitdrukking "3,1" deur die uitdrukking "3" te vervang.

2. Regulation 10 is hereby amended -

- (a) by the addition to subsection (2) of the following proviso:

“Provided that in the case of such a member who in terms of section 14(4)(b)(i) of the Government Service Act, 1980 (Act 2 of 1980), is allowed to retire, the annuity calculated in accordance with the provisions of paragraph (a) shall be reduced by 0,25 per cent for every month of the period between the date on which such member retires and the date on which he will attain the pensionable age.”;

- (b) by the substitution in subregulation (3) for the words preceding paragraph (a) of the following words:

“The provisions of subregulation (2), excluding the proviso thereto, shall apply *mutatis mutandis* to a member -”;

- (c) by the deletion in subparagraph (i) of subregulation (4)(a) of the words “who has not yet attained the pensionable age and”; and

- (d) by the substitution for subparagraph (i) of subregulation (4)(b) of the following subparagraph:

“(i) ‘pensionable age’, where that expression occurs in subparagraph (aa), shall not include a period during which a member held an office referred to in section 10A of the Government Service Act, 1980;”.

3. The provisions of -

- (a) paragraph 1 of this Schedule shall come into operation on 1 January 1989;
- (b) paragraphs 2(c) and (d) of this Schedule shall be deemed to have come into operation on 1 November 1988.

“(i) beteken ‘pensioengewende diens’, waar daardie uitdrukking in subparagraph (aa) voorkom, nie ook ’n tydperk waartydens ’n lid ’n amp bedoel in artikel 10A van die Regeringsdienswet, 1980, beklee het nie;”.
