#### AMENDMENT OF REGULATIONS MADE UNDER THE POLICE ACT, 1958 (ACT 7 OF 1958)

The Administrator-General has under section 33 of the Police Act, 1958 (Act 7 of 1958), further amended the regulations promulgated under Government Notice R.203 of 1964 as set out in the Schedule.

#### SCHEDULE

“(e) on account of voluntary resignation, if he is a member below the rank of officer who has served for a continuous period of at least three years and has given at least three calendar months prior notice in writing to the Commissioner of his intention to resign: Provided that, subject to the provisions of regulation 11(1)(b)(iv) a member, other than an officer, who has not served for a continuous period of at least three years shall not be entitled to resign from the Force by giving notice in writing: Provided further that, subject to the provisions of subregulation (3) and with due regard to the provisions of subregulation (2), any member, other than an officer, may, after written notice of at
