Enigiemand wat beswaar het teen enige van die onderstaande handelsmerke kan, binne die voorgeskrewe tydperk op vorm SM 6, vervat in die Tweede Bylae van die Handelsmerke-regulasies in Suidwes-Afrika, 1973, Kennisgewing van Beswaar indien. Any person who has grounds for objection to any of the following trade marks may, within the prescribed time, lodge Notice of Opposition on form SM 6 contained in the Second Schedule to the Trade Marks Rules in South West Africa, 1973. The prescribed time is two months after the date of advertisement. This period may on application be extended by the Registrar.

Formele beswaar moet nie ingedien word voordat die applikant om registrasie per brief van die beswaar in kennis gestel is nie, ten einde hom in die geleentheid te stel om sy aansoek terug te trek voordat onkoste in verband met die opstel van 'n Kennisgewing van Beswaar aangegaan word. By gebreke van so 'n kennisgewing aan die applikant, kan koste teen die beswaarmaker uitgewys word.

Formal opposition should not be lodged until after notice has been given by letter to the applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failing such notice to the applicant an opponent may not succeed in obtaining an order for costs.

OFFICE PRACTICE NOTICE NO 1/1990

RE: EXAMINATION OF NEW TRADE MARK APPLICATIONS

1. Due to my having inherited from the Pretoria office some 2 200 unexamined trade mark applications, and being short staffed as well as wanting to be rid of this backlog as soon as possible, I have decided, as a temporary measure, to confine the examination of trade mark applications to search only for conflict among existing registered and all pending trade marks.
2. This section is taken in terms of the proviso to section 21, and by virtue of the exceptional circumstances above described. In the result such unexamined applications, as from 1st March 1990, will be advertised before acceptance, and a notice to that effect will be endorsed on each advertisement namely "Proceeding in terms of section 21 proviso-advertised before acceptance by reason of special circumstances."
3. Once the normal period of opposition has expired, and where no third party objections have been encountered, the applications will be treated as accepted and the registration Certificates issued. In those cases where objections are encountered and conditions imposed, which will not result in a greater protection than before advertisement, I have no intention of re-advertising them after acceptance, and this is no different to that followed under normal practice. Only in a few exceptional cases may it become necessary to re-advertise after acceptance.
4. Notwithstanding this change of practice, applicants are encouraged to voluntarily submit evidence of distinctiveness in any case where they consider that such would be called for in normal circumstances, and it is in the applicants own interest to do this. All concerned are reminded that the Act empowers the Registrar or Court to impose conditions on the entering of memoranda in terms of section 18 at any time before or after registration.
5. As soon as the backlog has been reduced to a more reasonable level, and/or my staff position is much improved, then I will review the matter with the object of restoring full examination procedures.
