DEVIATION OF A PORTION OF FARM ROAD 805: DISTRICT OF MALTAHÖHE

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the President has under section 22(1)(c) of the said Ordinance, in the district of Maltahöhe, deviated the portion of farm road 805 described in paragraph (a) of the Schedule and shown on sketch-map P1449 by the symbols A-C, from the route so described and

shown, to the route described in paragraph (b) of the Schedule and shown on sketch-map P1449 by the symbols B-C.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary for Works, Transport and Communication, Windhoek, during normal office hours.

SCHEDULE

- (a) From a point (A on sketch-map P1449) at the junction of district roads 804 and 811 on the farm Sandrücken 51 generally south-south-eastwards and more and more south-eastwards across the last-mentioned farm to a point (C on sketch-map P1449) on the common boundary of the said farm and the farm Portion 1 of Elisenhof 52.
- (b) From a point (B on sketch-map P1449) on district road 811 on the farm Sandrücken 51 generally southwards and more and more south-south-eastwards across the said farm to a point (C on sketch-map P1449) on the common boundary of the said farm and the farm Portion 1 of Elisenhof 52.

APPLICATION AND PROPOSAL THAT PORTIONS OF FARM ROAD 2702 BE CLOSED: DISTRICT OF OUTJO

It is hereby made known that -

- (a) in terms of section 16(3) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), application has been made to the Chairman of the Roads Board of Outjo that the portion of farm road 2702 described in Schedule I and shown on sketch-map P1454 by the symbols A-B-C, be closed; and
- (b) in terms of section 20(1) of the said Ordinance the Permanent Secretary for Works, Transport and Communication proposes that the portion of farm road 2702 described in Schedule II and shown on sketch-map P1454 by the symbols C-D, be closed.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the road to which the application and proposal refer and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days mentioned below lie open for inspection at the offices of the Permanent Secretary for Works, Transport and Communication, Windhoek, and the Roads Superintendent, Outjo, during normal office hours.

Every person having any objection to the above-mentioned application or proposal, or both the application and proposal is hereby commanded to lodge his objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Permanent Secretary for Works, Transport and Communication, Private Bag 12005, Ausspannplatz, 9000, within a period of thirty days from the date of publication of this notice.

SCHEDULE I

From a point (A on sketch-map P1454) on the common boundary of the districts Outjo and Kamanjab and the common boundary of the farms Uitsig 301 and Struispan 251 generally eastwards across the last-mentioned farm to a point (B on sketch-map P1454) on the last-mentioned farm; thence generally east-south-eastwards across the last-mentioned farm to a point (C on sketch-map P1454) on the common boundary of the last-mentioned farm and the farm Nubes 32.

SCHEDULE II

From a point (C on sketch-map P1454) on the common boundary of the farms Struispan 251 and Nubes 32 generally eastwards across the last-mentioned farm to a point (D on sketch-map P1454) on district road 2694 on the last-mentioned farm.
