AMENDMENT OF ELECTRICITY SUPPLY REGULATIONS

Notice is hereby given in terms of Section 243 (2) bis of the Municipal Ordinance, 1963 (Ordinance no. 13 of 1963) as amended, that the Municipality of Swakopmund hereby amends the Electricity Supply Regulations, promulgated under Government Notice 331 of 1952, as set out in the Schedule.

SCHEDULE

Item 5 of Chapter VII is hereby amended:—

- (a) by the substitution in subitem (a)(i) for the amounts "R20,61", "R24,03", "R27,45", "R30,87", "R34,29", and "R37,71" of the amounts "R25,61", "R30,28", "R34,95", "R39,62", "R44,29" and "R48,96", respectively;
- (b) by the substitution in subitem (b)(i) in the column under the heading "Single Phase" for the amounts "R18,35", "R21,77", "R25,19", "R28,61", "R32,03", "R35,45" and "R38,87" of the amounts "R22,10", "R26,77", "R31,44", "R36,11", "R40,78", "R45,45" and "R50,12", respectively, and in the column under the heading "Three Phase" for the amounts "R55,05", "R65,31", "R75,57", "R85,83", "R96,09", "R106,35" and "R116,61" of the amounts "R66,30", "R80,31", "R94,32", "R108,33", "R122,34", "R136,35" and "R150,36", respectively;

- (c) by the substitution in subitem (c)(i) in the column under the heading "Single Phase" for the amounts "R6,75", "R13,50" and "R20,25" of the amounts "R10,50", "R21,00" and "R31,50", respectively, and in the column under the heading "Three Phase" for the amounts "R20,25", "R40,50" and "R60,75" of the amounts "R31,50", "R63,00" and "R94,50", respectively;
- (d) by the substitution in subitem (d)(i)(a) for the amount "R7,16" of the amount "R8,30";
- (e) by the substitution in subitem (d)(i)(b) for the amount "R1,44" of the amount "R1,69"; and
- (f) by the substitution in subitem (f) for the amount "R0,015" of the amount "R0,019".
