MUDUMU AND MAMILI NATIONAL
PARKS

In terms of section 14(2) of the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975), it is hereby made known that the Administrator-General has under section 14(1) of the said Ordinance declared the areas defined in Schedules 1 and 2 below and with the names Mudumu National Park and Mamili National Park respectively, as nature reserves.

MUDUMU NATIONAL PARK
