PERI-URBAN DEVELOPMENT BOARD: AMENDMENT OF STANDARD BUILDING REGULATIONS: LÜDERITZ

The President has under section 40 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970), with effect from 1 April 1990 further amended the Water Supply Regulations set out in the regulations promulgated under Government Notice R.1830 of 1970 and adopted for the peri-urban area of Lüderitz in accordance with section 14 bis of the

Standards Act, 1962 (Act 33 of 1962), which adoption was made known by Government Notice 6 of 1975, as set out in the Schedule.

SCHEDULE

Appendix A to Chapter 10 is hereby amended -

- (a) by the substitution in paragraph (1)(a)(i); (1)(a)(ii); (1)(b) and (1)(c) for the amounts "R6,75"; "6,75"; "R0,68" and "R6,65" of the amounts "R9,70"; "R48,10"; "R0,98" and "R8,40" respectively; and
- (b) by the substitution for paragraphs (2) and (3) of the following paragraph:

"(2) MISCELLANEOUS CHARGES

- (c) For the connection of water supply following disconnection for infringement of these regulations R20,00
- (e) For the provision and laying of a water supply connection: the actual cost plus 15%
- (f) For the testing of a water meter on the request of the consumer: R3,00 plus the travelling cost of the meter-reader to and from the place of testing: Provided that this amount will be refunded if it is found that the meter over- or under-registers by more than 5%.".

AMENDMENT OF ELECTRICITY SUPPLY REGULATIONS

The council of the Municipality of Karasburg has under section 244(5) of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), further amended the Model Electricity Supply Regulations promulgated under Government Notice 109 of 1957 and applied to the said Municipality by Government Notice 9 of 1958, as set out in the Schedule.

The said amendments have been approved by the President under section 243 of the said Municipal Ordinance, 1963.

SCHEDULE

Appendix D is hereby amended -

(a) by the substitution in item 5(e)(iii) for the heading of the following heading:

"Testing and Replacement of Meters and Circuit Breakers";

(b) by the substitution for paragraph (b) of item 5(e)(iii) of the following paragraph:

"Circuit breakers:

If any consumer is not satisfied with the rating of the circuit breaker controlling his or her installation, such consumer shall apply for the replacement thereof against the following charges:

- (i) For a single-phase circuit breaker R20,00
 (ii) For a three-phase circuit breaker R30,00";
- (c) by the substitution in item 5(e)(iv)(a) for the amount "R1,75" of the amount "R10,00"; and
- (d) by the substitution in item 5(e)(iv)(b) for the amount "R2,00" of the amount "R15,00".
