#### CLOSING OF A PORTION OF FARM ROAD 2451: DISTRICT OF OTJIWARONGO

**MAGISTRATES' COURTS ACT, 1944:  
DESIGNATION OF OSHAKATI IN THE DISTRICT OF  
OWAMBO AS AN ADDITIONAL PLACE FOR THE  
HOLDING OF A COURT**

Under section 2 of the Magistrates' Courts Act, 1944 (Act 32 of 1944), I hereby amend -

- (a) Government Notice 2428 of 1972 by the substitution in the fourth column of the Table preceding Schedule A, under the heading "Place where courts will be held", for the word "Ondangwa" of the words "Ondangwa, (being the seat of magistracy), and Oshakati."; and
- (b) Government Notice 93 of 1986 by the insertion in the fourth column of paragraph 3 of the Schedule after the word "Ondangwa", of the word "Oshakati,".
