REQUEST THAT FARM ROAD 1993 BE CLOSED AND THAT A ROAD BE DECLARED A PROCLAIMED FARM ROAD (NUMBER 1993): DISTRICT OF KARIBIB

In terms of section 17(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Roads Board of Karibib requests that -

- (a) farm road 1993 described in Schedule I and shown on sketch-map P1463 by the symbols A-B-C, be closed; and
- (b) that a road described in Schedule II and shown on sketch-map P1463 by the symbols D-E-F-G, be declared a proclaimed farm road (number 1993).

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the road to which the request refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days mentioned below lie open to inspection at the offices of the Permanent Secretary for Works, Transport and Communication, Windhoek, and the Roads Superintendent, Usakos, during normal office hours

AMENDMENT OF CEMETERY AND CREMATORIUM REGULATIONS

The council of the Municipality of Windhoek has under section 242 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), further amended the Cemetery and Crematorium Regulations promulgated by Government Notice 235 of 1975 as set out in the Schedule.
