PROPOSAL THAT A TRUNK ROAD BE PROCLAIMED (NUMBER 6/2), THAT PORTIONS OF MAIN ROAD 55 BE CLOSED, THAT THE CLASSIFICATION OF PORTIONS OF MAIN ROAD 55 BE CHANGED, THAT DISTRICT ROADS BE CLOSED, THAT THE CLASSIFICATION OF PORTIONS OF DISTRICT ROADS BE CHANGED, THAT FARM ROADS BE PROCLAIMED, THAT FARM ROADS AND PORTIONS OF FARM ROADS BE CLOSED AND THAT THE CLASSIFICATION OF PORTIONS OF FARM ROADS BE CHANGED: DISTRICT OF GOBABIS

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Gobabis -

- (a) on land where no road previously existed, a road as described in Schedule I and shown on sketch-map P1491 by the symbols F-G-G5-H-J-K-L-M-N be declared a proclaimed trunk road (number 6/2);
- (b) the portions of main road 55 described in each one of Schedules II, III, IV and V and shown on sketch-map P1491 by the symbols F-F27, F1-F2-F3, F5-F6-F7-F8 and F10-F11, respectively, be closed;
- (c) the classification of the portion of main road 55 -
 - (i) described in Schedule VI and shown on sketch-map P1491 by the symbols A-B-C-D-E-F, be changed to trunk road (number 6/2);
 - (ii) described in each one of Schedules VII, VIII and IX and shown on sketch-map P1491 by the symbols F8-F9-F10, F13-F26 and F26-F14-F15-F16-F17-F18-F19-F20-F21-F22-F23-F24-F25, respectively, be changed to district roads 1707, 1681 and 1739, respectively; and
 - (iii) described in each one of Schedules X, XI and XII and shown on sketch-map P1491 by the symbols F27-F1, F3-F4-F5 and F11-F12-J15-F13, respectively, be changed to farm roads 1656, 1704 and 1689, respectively;

- (d) the portions of district road 1692 described in each one of Schedules XIII and XIV and shown on sketch-map P1491 by the symbols G2-H1 and H2-H3-H4-H5-H6, respectively, be closed;
- (e) the classification of the portions of district roads 1601 and 1692 described in each one of Schedules XV, XVI, XVII and XVIII and shown on sketch-map P1491 by the symbols F1-G5, G5-G1-G2-G3-G4, H1-H2 and H6-H7, respectively, be changed to farm roads 1656, 1771, 1686 and 1690, respectively;
- (f) the road and the portion of the road described in each one of Schedules XIX and XX and shown on sketch-map P1491 by the symbols A1-A2 and J7-J8, respectively, be declared farm roads (numbers 1687 and 1827, respectively); and
- (g) the portions of farm roads 1610, 1690, 1822, 1689, 1691, 1683, 1820 and 1608 described in each one of Schedules XXI to XXIX and shown on sketch-map P1491, be closed.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the roads to which the proposal refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Gobabis, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Chairman of the Roads Boards, Private Bag 12005, Ausspannplatz, 9000, within a period of thirty days from the date of publication of this notice.

AMENDMENT OF WATER SUPPLY REGULATIONS

The council of the Municipality of Windhoek has under section 242 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), further amended the Water Supply Regulations promulgated by Government Notice 138 of 1973, as set out in the Schedule.

The said amendments have been approved by the President under section 243 of the said Municipal Ordinance, 1963.

SCHEDULE

Annexure A is hereby amended -

(a) by the substitution for paragraph 1 of the following paragraph:

“1. BASIC CHARGE:

Each consumer shall, in addition to any other tariff payable in terms of any other paragraph of this Annexure, pay the following basic charge to the council, whether water was consumed or not, determined according to the diameter of the meter inlet:

Diameter of meter inlet	Basic monthly charge
15 mm	R7,75 which amount includes 5 kilolitres of water;
20 mm	R15,50 which amount includes 10 kilolitres of water;
25 mm	R23,25 which amount includes 15 kilolitres of water;
40 mm	R38,75 which amount includes 25 kilolitres of water;
50 mm	R54,25 which amount includes 35 kilolitres of water;
80 mm	R77,50 which amount includes 50 kilolitres of water;
100 mm	R100,75 which amount includes 65 kilolitres of water;
150 mm and bigger	R139,50 which amount includes 50 kilolitres of water”; and

(b) by the substitution for paragraph 2 of the following paragraph:

“2. TARIFF BASED ON CONSUMPTION:

For consumption in excess of the volume included in the basic tariff an amount of R1,55 is payable per kilolitre for every kilolitre of water consumed”.
