CREATION OF DISTRICT DIVISIONS AND ESTABLISHMENT OF COURTS FOR SUCH DIVISIONS: MAGISTRATES' COURTS ACT, 1944

Under section 2 of the Magistrates' Courts Act, 1944 (Act 32 of 1944), and upon report of the Public Service Commission referred to in section 3(3) of the said Magistrates' Courts Act, 1944, I hereby -
(a) create the district divisions consisting of the number of districts as set out in column 2 of the Schedule, and declare the name by which such district division shall be known, which name is set out in column 1 of the Schedule opposite to each such district division;
(b) appoint the places as set out in column 3 of the Schedule opposite each such district division, as a place within such district division for the holding of a court for such district division;
(c) specify one place as set out in column 4 of the Schedule opposite each such district division, in addition to the places as aforesaid, as the seat of the magistracy for the holding of a court for that district division;
(d) establish a court for each such district division;
(e) repeal Government Notice 93 of 1986, and any amendments thereof; and
(f) determine 28 February 1994 as the date of coming into operation of this Government Notice.

## MINISTRY OF JUSTICE

## REDEFINITION OF THE LOCAL LIMITS OF DISTRICTS AND CREATION OF NEW DISTRICTS IN NAMIBIA: MAGISTRATES' COURTS ACT, 1944

Under section 2 of the Magistrates' Courts Act, 1944 (Act 32 of 1944), I hereby -
(a) redefine the local limits of the districts referred to in column 1 of the Schedule as set out in the annexure referred to in column 2 of the Schedule opposite each such district;
(b) declare that such districts shall from the date of coming into operation of this notice be known by the name set out in column 3 of the Schedule opposite each such district;
(c) establish a court for each such district;
(d) appoint the places set out in column 4 of the Schedule opposite each such district as places for the holding of a court for such district, and where more than one place is appointed, specify in the said column 4 one place as the seat of magistracy;
(e) appoint the places set out in column 5 of the Schedule as places for the holding of a periodical court, and prescribe as set out in the annexure referred to in column 6 of the Schedule opposite each such place the local limits within which such periodical court shall have jurisdiction;
(f) detach as a subdistrict the portions of a district as set out in the annexure referred to in column 7 of the Schedule to form the area of jurisdiction of a detached court, and declare that such subdistrict shall be known by the name set out in column 8 of the Schedule opposite each such subdistrict;
(g) annex for court purposes -
(i) to the district of Rehoboth, that part of the district of Windhoek as set out in the annexure referred to in column 6 of the Schedule and which has been included in the local limits of the periodical court at Nauchas;
(ii) to the district of Mariental -
(aa) that parts of the districts of Rehoboth and Windhoek as set out in the annexure referred to in column 6 of the Schedule and which have been included in the local limits of the periodical court at Kalkrand; and
(bb) that part of the district of Windhoek as set out in the annexure referred to in column 6 of the Schedule and which has been included in the local limits of the periodical court at Derm; and
(iii) to the district of Ondangwa, that part of the district of Tsumeb as set out in the annexure referred to in column 6 of the Schedule and which has been included in the local limits of the periodical court at Okatope;
(h) repeal Government Notices 1148 of 1972 and 2428 of 1972, and any amendments thereof; and
(i) determine 28 February 1994 as the date of coming into operation of this Government Notice.

## ANNEXURE A - KARASBURG

Name of district: Karasburg.
Name of place specified as the seat of magistracy for the district: Karasburg. The local limits of the Magisterial District of Karasburg shall be defined as follows:

Beginning at the northernmost corner beacon of the Farm Bergland 380 in the middle of the Gaab River; thence generally in a south-westerly direction along the middle of the Gaab River to its junction with the Fish River; thence generally in a southerly direction along the middle of the Fish River to a point where it intersects the northern boundary of Fish River Canyons 381; thence generally in a north-westerly and southerly direction along the boundary of and including the farm Fish River Canyons 381 to a point where the south-eastern boundary of the last-mentioned farm intersects the middle of the Fish River; thence generally in a south-westerly direction along the middle of the Fish River to its confluence with the Orange River; thence generally in a south-easterly and easterly direction along the middle of the Orange River to a point where it intersects the meridian of longitude $20^{\circ}$ east, the boundary common to the Republic of Namibia and the Republic of South Africa; thence generally in a northerly direction along the said meridian of longitude $20^{\circ}$ east to the north-eastern corner beacon of the farm Gansvley Nord 287; thence generally in a westerly direction along the boundaries of and including the following farms: Gansvley 468, Gideonsbron 464, Remainder of Swartkopstraat 279, Portion 1 of Swartkopstraat 279, Remainder of Swartkopstraat 279, Portion 2 of Frislar 278, Portion 1 (Klawervlei) of Frislar 278, and Portion A of Hohedün 277, to the northernmost corner beacon of the last-mentioned farm; thence generally in a westerly direction along the boundary of and excluding Portion 9 (Wilhesta) of the farm Tränental 299 in the District Keetmanshoop to the westernmost corner beacon of the said Portion 9 (Wilhesta); thence generally in a northerly, westerly and southerly direction along the boundaries of and including Portion 5 (Rooikoppe) of the farm Tränental 299 to the south-westernmost corner beacon of the said Portion 5 (Rooikoppe); thence generally in a south-easterly direction along the boundaries of and excluding the following properties in the Keetmanshoop district: Remainder of Schanzen 281, Smitsdrif 416, Portion 2 of Gugunas 301, Portion 3 of Gugunas 301, and Portions A, 4 and B of the farm Plattbeen 300, to the southernmost corner beacon of the last-mentioned property; thence generally in a westerly direction along the boundaries of and including the following properties: Remainder of Hohedün 277, Remainder of Tsaraxaibes 275, Portion 1 (Smorenswind) of Tsaraxaibes, Portion 1 of Portion B of Numdis 274, Portion 1 of Hängas 273, Stinkboom 272, Portion 2 (Noupoort) of Huams 271, Portion 1 (Stormlaagte) of Sandmund 270, Portion 2 (Steelkop) of Uitval 165, Remainder of Uitval 165, Portion 3 of Portion A of the farm Naos 79, Remainder of Uitval 165, Portion A of Uitval 165, Portion 1 of Portion A of Krantzberg 164, Remainder of Krantzberg 164, Portion 6 of Portion 5 of Krantzberg 314, Portion 3 (Selderus) of Garis 163, Remainder of Portion 2 (Grootgenoeg) of Garis 163, Portion 4 (Witkrans) of Portion 2 (Grootberg) of Garis 163, Rishon (Consolidated) 365, Portion A of the farm Us 162, excluding Portions 2 and 3 of Portion A of the last-mentioned farm, Portion 10 (Portion of Portion B) of Us 162, Remainder of Genadendal 264, Remainder

Beginning at a point on the coastline of the Atlantic Ocean where it intersects latitude $25^{\circ}$ south; thence generally in a southerly direction along the said coastline and including the off-shore islands Hollam's Bird, Mercury, Ichaboe, Seal, Penguin, Halifax, Long (North and South), Possession, Albatross, Pomona, Plum Pudding and Sinclair (also called Roast Beef), to a point where it intersects the middle of the Orange River; thence generally in a north-easterly direction along the said middle of the Orange River to a point where it intersects the middle of the Fish River; thence generally in a north-easterly direction along the middle of the Fish River to a point where it intersects the south-eastern boundary of the farm Kochas 113 in the Bethanie District; thence generally in a south-westerly direction along the boundary of and excluding the said farm Kochas 113 in the Bethanie District to the south-western corner beacon of the last-mentioned farm; thence generally in a south-westerly and north-westerly direction along the boundaries of and excluding the following farms in the Bethanie District: Mara 114, Wegdraai 179, Bobbejaankrans 180, Moedhou 182, Quaggaspoort 79, Uitsig 82 and Arimas 83, to the southernmost corner beacon of the last-mentioned farm; thence generally in a north-westerly direction along the boundaries of and including the following farms: Remainder of Zebrafontein 87, Kolke 84, Remainder of Aub 81, Portion 1 of Aub 81, Geelperdshoek 76, Kliphoek 72, Kanies 71, Rooiberg 70, Ruspunt 69, Pockenbank 68, Portion 2 (Kampte) of Kokerboomkloof 65, Remainder of Kokerboomkloof 65, Portion 1 of Kokerboomkloof 65, Nu-Harris 141, Remainder of Sabidas 66, excluding Portion 2 thereof, Nu-Harris 141, Groenboom 124, Tsachanabis 20, Farm 147, Werda 145, Sardkop 110, Rem. of Duinsig 139, Portion 1 (Welgemoed) of Duinsig 139, Remainder of Neisip 34, Portion 1 (Neisip Wes) of Neisip 34, Farm 108, Excelsior 59, Marico 58, Nabibis 30, Portion 3 of Garub Urus 6, Portion A (Landsberg) of Garub Urus 6, Kottbus 4, Portion 1 of Portion A of Sinclair Mine 2, Remainder of Portion A of Sinclair Mine 2, Klein Haremub 1, Portion 3 of the farm Ginas 20 and Klein Haremub 1, to the north-eastern corner beacon of the last-mentioned farm; thence generally in a south-westerly and north-westerly direction along the boundaries of and including the following farms: Klein Haremub 1, Remainder of Portion A of Sinclair Mine 2, Portion 1 of Portion A of Sinclair Mine 2, Kottbus 4, Portion A (Landsberg) of Garub Urus 6, Portion 2 of Koiimasies Namtib 5,
