- the return journey be commenced within 36 (thirty six) hours after the completion of the forward journey;
 - no persons may be picked up or set down *en route*;
 - the same persons be conveyed on both the forward and return journeys; and
 - the normal scheduled service, set out in paragraph 1 above, may not be curtailed to undertake trips in terms of the authority set out in this paragraph.
