AMENDMENT OF PROCLAMATION 67 OF 1958

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister has under section 22(1)(b) of the said Ordinance amended the declaration of district road 1989 by the substitution for the description of that road in Schedule II to Proclamation 67 of 1958 of the description of that road as set out in the Schedule and shown on sketch-map P1539 by the symbols A-B-C-D.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, during normal office hours.

SCHEDULE

"District Road No. 1989

From a point (A on sketch-map P1539) on district road 1914 on the farm Gross Aukas 68 generally south-westwards across the said farm and the farm Remainder of Noab 69 to a point (B on sketch-map P1539) on the last-mentioned farm; thence generally south-westwards and more and more south-westwards across the last-mentioned farm and the farm Remainder of Tsawisis 16 to a point (C on sketch-map P1539) on the last-mentioned farm; thence generally south-south-westwards and more and more southwards across the last-mentioned farm and the farm Remainder of Bergrus 94 to a point (D on sketch-map P1539) at the junction with farm road 1912 near the homestead of the last-mentioned farm."

COUNCIL FOR HEALTH AND SOCIAL SERVICES PROFESSIONS ACT, 1993: PROCEDURES FOR THE ELECTION BY PERSONS REGISTERED UNDER THE ALLIED HEALTH SERVICES PROFESSIONS ACT, 1993, OF MEMBERS FOR APPOINTMENT TO THE COUNCIL FOR HEALTH AND SOCIAL SERVICES PROFESSIONS

The Minister of Health and Social Services, in terms of section 5(1)(g) of the Council for Health and Social Services Professions Act, 1993 (Act 29 of 1993), has determined the procedure for the election of three persons registered in terms of the Allied Health Services Professions Act, 1993 (Act 20 of 1993) for appointment as members of the Council for Health and Social Services Professions, as set out in the Schedule.

SCHEDULE

ELECTION BY PERSONS REGISTERED UNDER THE ALLIED HEALTH SERVICES PROFESSIONS ACT, 1993, OF MEMBERS FOR APPOINTMENT TO THE COUNCIL FOR HEALTH AND SOCIAL SERVICES PROFESSIONS

Interpretation

1. In these regulations, unless the context otherwise indicates, an expression in the Act has a corresponding meaning, and -

"Board" means a Board established under the Allied Health Services Professions Act, 1993 (Act 20 of 1993) for the profession or professions concerned;

"candidate" means a person nominated in accordance with regulation 3(1) to be a candidate in an election;

"committee" means a committee consisting of not more than 5 persons practising an allied health services profession and whose names appear in the register in respect of such allied health services profession, appointed by the Minister for the purpose of regulation 2;

"election" means a meeting held in accordance with regulation 5 to elect three persons for appointment as members of the Council as contemplated in section 5(1)(g);

"notice in writing" means a notice in writing sent by pre-paid registered or certified mail to the address of the addressee as it appears in the register or in the records of the Board concerned, as the case may be; "register" means a register contemplated by section 48(1)(a) of the Allied Health Services Professions Act, 1993 (Act 20 of 1993), in respect of an allied health services profession;

"registration number" means -

- (a) in relation to a person registered with a Board, the number under which such person is so registered; and
- (b) in relation to a person whose name has been entered into a register, the number in such register against which such name is so entered;

"representative" means a person appointed in accordance with regulation 2 to vote at an election;

"returning officer" means an officer in the Ministry of Health and Social Services designated by the Minister as returning officer to assist the registrar in the conducting of an election;

"section" means a section of the Act; and

"the Act" means the Council for Health and Social Services Professions Act, 1993 (Act 29 of 1993).

Appointment of representatives

- 2. (1) For the purpose of the election of the three persons for appointment to the Council in accordance with section 5(1)(g) -
 - (a) every Board, every such Board acting independently; and
 - (b) every committee appointed by the Minister in respect of a register, every such committee acting independently in respect of the allied health services profession to which the register concerned relates,

shall from their respective professions appoint not more than five persons in respect of every such Board and not more than five persons in respect of every such allied health services profession, which persons so appointed shall act as the representatives of the respective Boards and of the prospective allied health services professions at the meeting to be held in accordance with regulation 5 for the election of the three persons for appointment in accordance with that section.

(2) The Boards and the committees referred to in paragraphs (a) and (b) of subregulation (1) respectively shall, within a period of 30 days after the posting by the registrar of a notice in writing addressed to such Boards and to such committees requesting particulars of the names, occupations, residential addresses, postal addresses, telephone numbers and registration numbers of the representatives referred to in that subregulation, in writing submit such particulars to the registrar, Council for Health and Social Services Professions, Private Bag 13198, Windhoek, or at such other address as the registrar in such notice in writing may specify.

Nomination of candidates for election

- 3. (1) The registrar shall, by notice in writing addressed to every representative referred to in regulation 2(2), request such representatives to nominate in respect of each Board and in respect of each allied health services profession referred to in paragraphs (a) and (b) of regulation 2(1) respectively, not more than two candidates and to in writing submit to the registrar at the address, and within the period or before the date, as the case may be, specified in such notice, the names, occupations and registration numbers of such candidates so nominated, together with an acceptance of nomination by such candidates.
- (2) If, in accordance with the procedures provided for in subregulation (1) -
 - (a) three candidates only are nominated, the registrar shall, without conducting an election, declare such three candidates so nominated, for the purposes of section 5(1)(g), to be duly elected; or
 - (b) less than three candidates are nominated, the registrar shall repeat the procedures provided for in subregulation (1); or
 - (c) more than three candidates are nominated, the registrar shall conduct an election in accordance with these regulations.
- (3) If, after a repeat of the procedures referred to in subregulation (2)(b), less than three candidates are again nominated as provided for in subregulation (1), the Minister may in accordance with section 5(5) appoint the three members referred to in section 5(1)(g).

Convening of meeting for election of persons for appointment as members of Council

- 4. (1) The registrar shall, for the purpose of an election contemplated in regulation 3(2)(c), by notice in writing addressed to every representative referred to in regulation 2(2), convene a meeting of such representatives for the purpose of the election of the three persons for appointment by the Minister as members of the Council in accordance with section 5(1)(g).
- (2) The notice referred to in subregulation (1) shall specify the venue, date and time of the meeting contemplated in that subregulation.

Meeting for election of persons for appointment as members of Council

- 5. (1) The registrar shall act as chairperson of the meeting convened in accordance with regulation 4, in this regulation referred to as "the meeting" and shall conduct the election for which purpose the meeting was convened.
- (2) One-half plus one of all the representatives referred to in regulation 2(2), if present at the meeting, shall constitute a quorum for the meeting.

- (3) If, at the commencement time of the meeting specified in a notice referred to in regulation 4(1), a quorum is not present at the meeting, the registrar shall adjourn the meeting and the Minister shall in accordance with section 5(5) appoint the three members referred to in section 5(1)(g).
- (4) The registrar shall, to each representative present at the meeting, hand one ballot paper, prepared by the registrar, on which the full names of all the candidates shall appear in alphabetical order, together with their respective occupations.
- (5) The ballot paper referred to in subregulation (4) shall be in such form and, subject to that subregulation, contain such particulars as the registrar may determine.
- (6) A representative present at the meeting may, on the ballot paper referred to in subregulation (4) handed to him or her, vote for not more than three candidates, and shall cast such votes by marking an "X" opposite the names of each of the candidates he or she wishes to vote for and shall thereafter place such ballot paper into a closed ballot box.
 - (7) Every representative shall be entitled to a secret vote.
- (8) The registrar and the returning officer, in the presence of the representatives at the meeting, shall open the ballot box, remove the ballot papers from the ballot box referred to in subregulation (6), discard the spoilt ballot papers and ascertain the number of votes cast for each candidate.
 - (9) The registrar's decision on a spoilt ballot paper shall be final.
- (10) The three candidates in respect of whom the greatest number of votes have in accordance with subregulation (6) been recorded, shall be declared duly elected for appointment by the Minister in accordance with section 5(1)(g).
- (11) In the event of an equality of votes cast in accordance with subregulation (6) in respect of two or more candidates, and if such equality of votes affects the result of the election, a second ballot shall be conducted by the meeting, *mutatis mutandis* in accordance with this regulation, but only in respect of such two or more candidates.
- (12) If the second ballot contemplated in subregulation (11) does not produce a final result, then the registrar shall determine the manner in which the deadlock shall be resolved, or may adjourn the meeting and refer the matter to the Minister for appointment of the three members in accordance with the procedure referred to in subregulation (3).
- (13) The registrar shall, within seven days after an election, in writing submit to the Minister the names, addresses and occupations of the candidates elected in accordance with these regulations, or refer the matter to the Minister for appointment of the three members as contemplated in subregulation (3) or (12), whichever may be applicable.

- (c) in terms of section 3(4)(b) of the said Ordinance that the Minister has under section 3(4)(aA) of the said Ordinance, in the district of Ovambo, decreased the width of the road reserves of district roads 3602, 3604, 3607, 3608, 3616, 3617, 3619, 3625, 3626, 3628 and 3700 to thirty metres; and
- (d) for general information that the number of the portion of district road 3605 described in Schedule VIII and shown on sketch-map P1526 by the symbols N-O-P has been changed to 3606.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

NOTICE OF INTENDED CLOSURE OF CERTAIN ROADS TO CERTAIN CLASSES OF TRAFFIC

In terms of section 50(3)(a)(ii) of the Local Authorities Act, 1992 (Act 23 of 1992) notice is hereby given that the Municipal Council of Mariental intends under section 50(1)(a)(ii) of the said Act to close the streets mentioned in Column II of the Schedule, situated in the township mentioned in Column I of the Schedule for the duration or period mentioned in Column III of the Schedule opposite each such street, to all traffic with a gross mass exceeding 5 tons.
