- (a) determined that the surface and airmail rates to be demanded or received in respect of postal services as well as parcels rendered by the Company with regard to postal articles destined for delivery in any country other than Namibia shall with effect from 1 April 1995 be as set out in the Schedule; and

(b) repealed General Notice 63 of 1994 with effect from 1 April 1995.
