- (d) the condition that the mentioned written consent shall at all times be kept on the relative taxi together with the road carrier permit relating to that vehicle and be produced upon demand by an authorised officer.

2. Not more than 14 (Fourteen) taxi-passengers (driver included) and their personal luggage on *bona fide* taxi trips - From places situated within that portion of Walvis Bay municipal area generally known as Narraville to the C.R. Swart bridge south of Swakopmund and return subject to the conditions:
 - (a) that no persons may be picked up or set down at any other taxi rank within Walvis Bay municipal area;
 - (b) that the vehicle specified in the road carrier permit, to which this annexure relates, is registered in the name of the holder;
 - (c) that the holder of the permit is prohibited to enter into an agreement whereby any other party will be authorised to undertake road transportation for his/her own benefit under the authority given by the road carrier permit to which this annexure relates; and
 - (d) the conditions set out in the attached annexure.

ANNEXURE:

1. The holder or his servant may not after being hired for a specific trip pick up any other passenger for the same trip or any portion thereof without the consent of the hirer.
2. The holder or his servant may not make known by means of an advertisement or in any other manner that he is prepared to undertake conveyance outside his authorised area.

4. The holder furthermore has to identify his vehicle according to the provisions of regulation 2 of the Road Transportation Regulations, 1977.
5. The holder of the road carrier permit, to which this annexure relates, may not enter into an agreement with any other person whereby the said road carrier permit is rented or leased by the other person.
