REGULATIONS RELATING TO WATER CONSERVATION

The Council of the Municipality of Windhoek under section 94(1)(a) of the Local Authorities Act, 1992 (Act 23 of 1992), hereby makes the regulations as set out in the Schedule.

SCHEDULE**REGULATIONS RELATING TO WATER CONSERVATION**

1. In these regulations, unless the context indicates otherwise -

“City Engineer” means a person employed by the Council of the Municipality of Windhoek in the capacity of City Engineer in the Department of Water Services, or his or her duly appointed substitute;

“occupier” in relation to premises, means any person who is the owner, lessee, or otherwise has the management, charge, control, or use of any premises, whether such person resides on such premises or not; and

“water installation” includes all pipes, fittings, or apparatus used or intended to be used for or in connection with the supply of water by the Council of the Municipality of Windhoek, but excluding any communication pipe leading from a water main to the street boundary of a premises concerned.

2. No occupier shall cause or permit any wastage, misuse, or undue consumption of water on his or her premises.

3. Where in the opinion of the City Engineer any part of a water installation on any premises is in such a state of disrepair that it causes or is likely to cause a wastage of water, he or she may -

- (a) serve the occupier of such premises with a written notice requiring him or her to repair or replace, as the case may be, such part of the water installation within a period specified in the notice;
- (b) if the occupier fails to comply with the notice referred to in subparagraph (a), without prior notice, take such measures as are necessary to repair or replace the part of the water installation in question, and the Council may recover the costs thereof from the occupier concerned.

4. (1) No person shall water any garden between 10:00 and 16:00 hours on any day without prior written approval of the Council.

(2) Subject to subparagraph (3), no person shall wash any vehicle with a hose pipe.

(3) Any enterprise carrying on a trade or business of washing vehicles may use a hose pipe only with the prior written approval of the City Engineer and on such conditions as may be determined by the City Engineer.

(4) No person shall wash any driveway or paved area by means of a hose pipe or a fire hydrant.

5. (1) Subject to regulation 7, an occupier on whose premises an outdoor swimming pool is installed, shall, when the swimming pool is not used -

(a) cover that swimming pool with a pool cover; or

(b) provide a shade cloth structure direct over the swimming pool and provide a windproof structure directly adjacent to such swimming pool; or

(c) take any other measure approved by the City Engineer in writing that will minimise the rate of evaporation of water from such swimming pool.

(2) For the purposes of subregulation (1) "swimming pool" means a swimming pool situated on a residential erf.

(3) Subject to regulation 7, no occupier shall permit or allow the use of a showerhead on his or her premises, unless such showerhead restricts the flow of water to a maximum of ten litres of water per minute.

6. (1) Subject to regulation 7, no person shall install an automatic cistern or tipping tank for flushing an urinal.

(2) Where an automatic cistern or tipping tank was installed before these regulations came into operation, the occupier concerned shall close such cistern or tipping tank when not in use.

7. Regulations 5(1) and (3) and (6)(1) shall come into operation 120 days from the day on which this notice comes into operation.

8. Any person who fails to comply with any of the provisions of regulation 2, 3, 4, 5 or 6 shall be guilty of an offence and on conviction be liable to a fine not exceeding N\$2 000,00 or, in default of payment, to imprisonment for a period not exceeding six months.
