ELECTORAL ACT, 1992: BY-ELECTION IN KATIMA MULILO CONSTITUENCY: DETERMINATION OF DAY AND PLACE FOR SUBMISSION OF NOMINATION OF CANDIDATES AND POLLING DAY AND NOTIFICATION OF NAME OF RETURNING OFFICER

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act 24 of 1992), I hereby make known-

- (a) that I have under paragraph (a) of that subsection determined -
 - (i) Friday, 6 September 1996, as the day on which a public sitting shall be held in the Katima Mulilo constituency in the Caprivi Region for the submission of nomination of candidates for election as a member of the Regional Council for that Constituency; and
 - (ii) that the said public sitting shall be held at the Magistrate's Court, Katima Mulilo, from 09:00 until 11:00 on that day;
- (b) that, if a poll becomes necessary in the said constituency for the reason that more than one person shall have been duly nominated at the close of the said sitting, the poll shall be taken on 16 October 1996, commencing at 7:00 and closing at 21:00 on that day; and
- (c) that Mr A N Elago, Directorate of Elections, Windhoek has been appointed in terms of section 51 of the said Act as returning officer at the election.

**ELECTORAL ACT, 1992: DESIGNATION OF MAGISTRATE TO HEAR
APPEALS AGAINST REFUSAL TO REGISTER VOTERS AND
OBJECTIONS AGAINST THE SUPPLEMENTARY VOTERS' REGISTER
IN RESPECT OF THE KATIMA MULILO CONSTITUENCY**

Under the provisions of subsection (1) of section 19 of the Electoral Act, 1992 (Act 24 of 1992), I designate the Magistrate of Katima Mulilo to receive and hear appeals lodged in terms of that section against any refusal to register voters, or objections lodged in terms of section 22 against the inclusion of the names of persons on the supplementary voters' register, in respect of the registration of voters which will take place during the period 19 August 1996 to 24 August 1996 in the Katima Mulilo Constituency.
