AMENDMENT OF COMPANIES ADMINISTRATIVE REGULATIONS, 1973

The Minister has under section 15 of the Companies Act, 1973 (Act 61 of 1973), made the regulations set out in the Schedule.

SCHEDULE

1. In this Schedule "the Regulations" means the Companies Administrative Regulations promulgated under Government Notice R.1948 of 19 October 1973, as amended by Government Notices R.2384 of 14 December 1973; R.119 of 17 January 1975; R.1665 of 10 September 1976; R.1911 of 22 October 1976; R.787 of 6 May 1977; R.2044 of 7 October 1977 and R.1391 of 30 June 1978.

2. Regulation 2 of the Regulations is amended by the substitution for subregulation (4) of the following subregulation:

"(4) Subject to the provisions of section 57, 152(2)(b), 322(1)(a), 328 and 329(5) of the Act, all documents lodged with the Office shall be in the official language of Namibia.".

3. Regulation (4) of the Regulations is amended by the substitution for paragraph (a) of subsection (2) of the following paragraph:

"(a) When a translation of a document which is in a foreign language into the official language of Namibia is to be forwarded to or lodged with the Registrar, the translation shall be certified by a sworn or officially recognised translator or be otherwise verified to the satisfaction of the Registrar."

4. The following Schedule is hereby substituted for Schedule 2 of the Regulations:
