Under the powers vested in me by subsection (1) of section 122 of the Minerals (Prospecting and Mining) Act, 1992 (Act 33 of 1992), I hereby declare that no person other than the holder of a reconnaissance licence shall, notwithstanding anything to the contrary contained in the Act or any other law, but subject to any right conferred upon the holder of any mining claim, exclusive prospecting licence, mineral deposit retention licence or mining licence by that Act before the date of this notice, and which exists on the date immediately before the date of this notice, carry on any prospecting operations or mining operations in, on or under any part of the area known as Diamond Area No. 1 as defined in Schedule 1 to the Diamond Industry Protection Proclamation, 1939 (Proclamation 17 of 1939).

ANNOUNCEMENT OF PERIOD DURING WHICH APPLICATIONS FOR RIGHTS OF EXPLOITATION UNDER THE SEA FISHERIES ACT, 1992, MAY BE MADE.

Under section 14 (2) of the Sea Fisheries Act (Act 29 of 1992), I hereby announce that applications for rights of exploitation in respect of Linefish may be made during the period from 1 July 1998 to 31 July 1998, subject to the conditions and criteria set out in the schedule below.

SCHEDULE

1. The granting of the right of exploitation shall be subject to the conditions imposed by the Minister under section 14(4) of the Sea Fisheries Act, 1992.
2. The matters to which the Minister may have regard when considering an application for a right of exploitation are:-
 - a) in terms of section 14(6) of the Sea Fisheries Act, 1992:
 - i) whether or not the applicant is a Namibian citizen;
 - ii) where the applicant is a company, whether the beneficial control of the company is vested in Namibian citizens;
 - iii) the beneficial ownership of any vessel which will be used by the applicant;
 - iv) the ability of the applicant to exercise the right of exploitation in a satisfactory manner; and
 - b) in terms of regulation 2 of the Sea Fisheries Regulations promulgated under Government Notice No. 1 of 1993:-
 - i) the advancement of persons in Namibia who have been socially, economically or educationally disadvantaged by discriminatory laws or practices which have been enacted or practised before the independence of Namibia;
 - ii) regional development within Namibia;
 - iii) co-operation with other countries, especially those in the Southern African Development Community;
 - iv) the conservation and economic development of marine resources.
3. A right of exploitation under this notice shall be granted for a term of 4, 7 or 10 years in accordance with the Policy Statement referred to in Paragraph 5 below.
4. Applications already in possession of the Ministry will not be considered and all prospective applicants for rights of exploitation must apply anew.
5. The necessary application forms for rights of exploitation and a Policy Statement on the Granting of Rights of Exploitation to Utilise Marine Resources and on the Allocation of Fishing Quotas are obtainable on written request from the Permanent Secretary, Ministry of Fisheries and Marine Resources, Private Bag 13355, Windhoek, or on personal request at the Brendan Simbwaye Building, fourth floor, corner of Uhland and Goethe Streets, Windhoek.

6. The Council of the Municipality of Windhoek, under section 30(1)(u) of the Local Authorities Act, 1992 (Act 23 of 1992) amends the fees, charges and other moneys payable in respect of the supply of water and other services in the Water Supply Regulations promulgated under General Notice 367 of 1996 as set out in the Schedule.

SCHEDULE

Annexure A to the Water Supply Regulations is hereby amended by:

1. By the substitution for paragraph 1 of the following paragraph:

"1. **BASIC CHARGE:**

Each consumer shall pay, in addition to any other tariff payable in terms of any other paragraph of this Annexure, the following basic charge to the Council whether water was consumed or not, determined according to the diameter of the meter inlet:

2. By the substitution for subparagraph (1) of paragraph 2 of the following subparagraph:

"(1) For water supplied in excess of the volume included in the basic charge referred to in paragraph 1 -

(a) in the case of a consumer to whom water is supplied for domestic purposes or any other consumer provided with a communication pipe which is 25 millimetres or less in diameter -

(i) where the volume of water supplied during the period for which the meter reading was carried out amount to an average daily consumption not exceeding 0,200 kilolitre, for each kilolitre of water supplied in excess of the volume included in the basic charge N\$2.65

(ii) where the volume of water supplied during such period amount to an average daily consumption in excess of 0,200 kilolitre, but not exceeding 0,50 kilolitre -

(aa) for each kilolitre of water supplied in excess of the volume included in the basic tariff, but limited to such volume as is equal to an average daily consumption of 0,200 kilolitre - N\$2.65

(bb) for each kilolitre of water supplied in excess of the volume calculated in accordance with subparagraph (aa) - N\$3.90

(iii) where the volume of water supplied during such period amount to an average daily consumption in excess of 0,50 kilolitre but not exceeding 1,20 kilolitre -
